CARROLL COUNTY CIRCUIT COURT COPY REQUEST INSTRUCTIONS & FORM

The Carroll County Clerk's Office provides copies to customers through the mail and by personal request in the office.

- ♦ **The fee is \$0.50 per page to copy a Carroll County Circuit Court document.**
- ♦ **An additional fee of \$5.00 is required to receive a Gold Seal "Certification of True Copy" of a Carroll County Circuit Court document.**

Please call the Clerk's Office at **410-386-8720** for assistance in determining copy costs for your document(s) or for help with any other questions regarding obtaining copies of documents. These documents can include any Circuit Court cases beginning with **C-06, 06, C, K** or **P**.

Examples of Circuit Court documents that might need to be copied include but are not limited to: Divorce Decrees, Custody Agreements, Name Changes, Earning Withholding Orders, Qualified Domestic Relations Orders, Child Support Agreements, and any Criminal Case heard in Circuit Court.

*For a copy / certified copy of a Marriage Certificate, please call the Land Records & Licensing Department at **410-386-8760** to obtain the cost for those copies.*
